



## Coastal Habitat Campaign Coordinator

Job Announcement – February 20, 2020

The Audubon Society of Lincoln City (ASLC) seeks an experienced environmental campaign coordinator for its Coastal Habitat Campaign. This is an at-will position, estimated at 20 hours a week, and is funded for six months with the possibility of extension. The Coastal Habitat Campaign Coordinator will report to the chair of the Coastal Habitat Campaign Team and will work closely with the Team to achieve campaign goals. We have identified rocky habitats in Lincoln and Tillamook counties in need of protection and will be preparing and submitting proposals to Ocean Policy Advisory Council (OPAC).

Experience and skills sought include 1) coordinating successful grassroots campaigns; 2) building up awareness of and promoting environmental campaigns, 3) recruiting and working effectively with volunteers; 4) strong people skills including speaking, writing, and advocacy; and 5) a commitment to preserving and protecting the natural resources of the Oregon Coast for future generations. Knowledge of marine environments is desired.

You will work with the Coastal Habitat Campaign Team to:

- 1) Help promote greater public awareness of coastal rocky habitat in Lincoln and Tillamook counties by coordinating outreach to the media, including letters to the editor campaigns and opinion editorials. Work with professional writers, designers, and media experts as needed to produce promotional materials such as videos, brochures, and handouts.
- 2) Help to develop and implement strategies to increase decision-makers' awareness of coastal habitats – and the need to protect them.
- 3) Recruit and train volunteers for special campaign projects including testifying in support of coastal habitat protection at public meetings.
- 4) Support coastal habitats educational outreach to students.
- 5) Network with other environmental groups and partners. Ensure that the public and campaign partners are aware of public events related to coastal habitats. Maintain a calendar of these events.
- 6) Reach out to potential allies, such as tourism agencies and whale watch companies, and find means to engage and enroll them in the campaign.
- 7) Help organize a variety of outings such as boat trips, bird trips, hikes, and service projects for the public to learn more about coastal habitats.
- 8) Perform miscellaneous duties as required.

Qualified candidate must be able to work well with a team and work independently with minimum supervision. Hourly position, \$18.45 per hour, approximately 20 hours a week. Applicants must have a valid Oregon Driver's License, provide their own transportation, and reside in Tillamook or Lincoln county. Applicants must also provide and cover the cost of their own phone and computer services.
